**PUBLIC LIGHTING Curitiba City Hall releases bid** invitation for public lighting IMAGEM: MIKE KILCOYNE concession On April 25, 2022, the Curitiba City Hall published the bid invitation for the concession of the municipality's public

lighting service. The project aims to modernize, improve efficiency, expand, operate, and maintain the municipal lighting network infrastructure. The concession has a term of 23 years and investments of approximately BRL 324 million are expected. The envelopes with documents and proposals must be delivered to B3's headquarters on June 15, between 9 am and 12 pm. The public session will take place on June 21, at 2 pm, also at B3. On April 25, 2022, the Brazilian National Electric Energy Agency (ANEEL) published Normative Resolution No. 1,014/2022, which defines the criteria for the entry, maintenance, and withdrawal of agents in the energy market. of periodic evaluations to assess the companies' good financial health.

The new Normative Resolution establishes the improvement of security mechanisms for the sector – reinforcing the approval process and the monitoring of trading companies throughout the period of their operations by means The Normative Resolution defined that trading companies shall be classified into two types: (i) large-sized agents (Type 1), with no limitation for the registration of sales amounts in the Accounting and Settlement System (SCL) of the Energy Trading Chamber (CCEE), being required to prove net worth exceeding BRL 10 million, without, however, imposing entry barriers that could harm the sector competitiveness; and (ii) small-sized agents (Type 2), subject to the monthly limit of 30 MWav.

Referred rule came into effect on May 1, 2022. CCEE will have 60 days to send ANEEL the respective Trading Procedures that must be adapted to meet the regulation's requirements.

ANEEL rejects requests for registration order regarding offshore wind farms The Brazilian National Electric Energy Agency (ANEEL) rejected on April 5, 2022, by animous vote, requests for registrations made by agents of the energy sector interested in developing offshore wind power plants.

Nevertheless, the Ministry of Mines and Energy (MME) intends that the projects prior to the Decree should be adapted to the rules that still will be established.

A-5 and A-6 New Energy Auctions The Ministry of Mines and Energy (MME) published on April 18, 2022 the rules for the A-5 and A-6 auctions regarding the purchase of electricity from new generation projects, which will take place in September this year. Interested distribution companies must declare their participation in the auction to the MME between July 20 and

29, 2022, and must consider supplying the totality of the market, as of January 1, 2027 for the A-5 auction, and

For the A-5 auction, Energy Purchase Agreements in the Regulated Environment (CCEAR) will be negotiated in the modality by quantity, with a supply term of 20 years for Hydroelectric Generating Plants (CGH), Small Hydroelectric Power Plants (PCH), and Hydroelectric Power Plants (UHE), with power equal to or less than 50 MW, and expansion

of these existing hydro plants with power equal to or less than 50 MW. In the availability modality, with a 20-year supply term, CCEARs will be negotiated for the energy recovery projects of solid urban waste, biomass, national coal, and biogas-fueled thermoelectric plants.

The Brazilian National Petroleum, Natural Gas and Biofuels Agency (ANP) published, on April 18, 2022, Resolution ANP No. 875 establishing the criteria for setting the reference price of natural gas (PRGN). The criteria will be adopted for purposes of calculating the governmental participations referred to in Law No. 9,478/1997, in the cases

established by Decree No. 2,705/1998. This resolution decided to apply the PRGN also in the event the concessionaire fails to submit to the ANP, by the 15th day of the month following the sale of natural gas, the sales report accompanied by the respective invoices. In addition, the concessionaire must send the ANP the compositional analysis of its produced natural gas by the 5th day of the month following the start of production, and the ANP will publish each month the PRGN produced in the previous month in each field, for the purposes of collecting government and third

> 59 exploratory blocks are auctioned in the Third **Cycle of Permanent ANP Concession Offers**

On April 13, 2022, the ANP held the public session of the Third Cycle of Permanent Concession Offer (OPC), through which 59 exploratory blocks of oil and natural gas were auctioned by 13 companies, generating BRL 422,422,152.64 in signature bonus (premium of 854.84%). The blocks are distributed in 6 Brazilian basins, in the states of Rio Grande do Norte, Alagoas, Bahia, Espírito Santo, Santa Catarina, and Paraná, resulting in at least BRL

Public Consultation and Public Hearing on the proposed resolution aimed at extending the exploration phase deadlines

The ANP board of directors, on April 14, 2022, decided to approve the holding of a public consultation and hearing on a proposed resolution that gives oil and gas explorers and producers the possibility of extending the terms of the exploration phase of their respective contracts by 18 months. This norm will meet the demand made by the industry and aims to mitigate the impacts caused by the uncertainties in the sector brought by the COVID-19 pandemic. It is worth mentioning that this normative only became plausible in view of Resolution CNPE No. 12/2021, responsible for recommending the adoption of measures to extend the first phase of the concession and production sharing

contracts in effect, i.e., exploration.

**URBAN MOBILITY** Santos Port immersed tunnel project is qualified at PPI IMAGEM: HARI MENON

Through Decree No. 11,025, dated March 31, 2022, the President of the Republic qualified the studies of the Port of Santos' immersed tunnel project under the scope of the Partnership and Investment Program. The scope of the project is to solve the Port's operational and urban mobility problems between Santos and Guarujá, in order to minimize the commuting time between the municipalities. It is estimated that the project, which should be auctioned in the fourth quarter of 2022, will receive investments of BRL 4 billion. The resources for the construction of the tunnel will come from the concession of the Port of Santos itself, but both the construction

ANA approves proof of economic and financial capacity of water and sewage service providers in 2,766 municipalities and 18 states On April 20, 2022, the Brazilian National Water and Basic Sanitation Agency (ANA) released a <u>list of contracts</u> in which water and sewage service providers proved their economic and financial capacity to universalize water supply and sewage collection and treatment services by 2023. The final list released was elaborated from the information sent by municipal, inter-municipal and state regulatory agencies, according to Decree No. 10,710/2021. The evaluation of the economic and financial capacity is foreseen only for those providers that have already entered into additives to the program contracts foreseeing universalization goals. From now on, the responsible regulatory agencies will need to identify irregular contracts and demand that these incumbents regularize service provision.

The Brazilian Federal Government, through Decree No. 11,043/2022, published on April 13, established the National Solid Waste Plan (PLANARES), which presents in its content diagnoses, goals, guidelines, and actions aimed at improving the management of solid waste in Brazil. It is a long-term strategy for the operationalization of public policies nationwide, with the objective of materializing the forecasts of the National Policy for Solid Waste (PNRS), established by Law No. 12,305/2010. The plan will be published on the website of the National Solid Waste Management Information System (SINIR), a platform that presents maps, panels, and layers of information on solid
