ANPD: two years of oversight and enforcement in Brazil

On July 6th, ANPD marked two years since its first administrative sanction, reinforcing its role in enforcing Brazil's LGPD. Since 2023, the Authority has focused on oversight, issuing warnings and corrective measures, with only one monetary fine so far. With 76 processes and growing partnerships, ANPD promotes

compliance through regulation, education, and enforcement. Companies must align with its standards to ensure ethical and transparent data practices.
