The first innovation program structured by a full-service law firm in Latin America TozziniFreire has witnessed many transformations in society since it was founded in 1976, and **innovation has always been part of its manifesto**.

We have led pioneering initiatives in the Brazilian legal market, such as implementing the full open--space model in our offices since 2006, creating foreign desks to serve strategic global regions, and consolidating, unprecedentedly, key practice areas such as Compliance and Technology.

In 2016, we were the first full-service Brazilian law firm to dedicate an area especially for startups.

In this context, with the expertise acquired in this practice and observing the technological advances that have been emerging over the years, such as Artificial Intelligence, Blockchain, metaverse, electric vehicles, we emphasized the **urgent need for aligning the legal practice and the challenges of the 21st century**.

We then decided to expand the startups area and include more and more innovation to promote cultural and digital transformation within the law firm. The world was – and is – constantly and rapidly changing, and our professionals need to be prepared to navigate it.

Our initial structure was based on six pillars of transformation:



Events

Spaces

Promoting the installation of innovation spaces in the firm and positioning lawyers in creative work environments: coworking areas, design thinking rooms and relaxation areas.



Academy

Preparing our employees for the future through courses, studies and workshops aimed at disseminating knowledge related to technology, innovation, culture, and entrepreneurship.



Culture

Proposing changes in people's mindset by engaging them in entrepreneurial culture and generating value for our clients.



Tech

March: Pandemic

The Covid-19 pandemic has made uncertainty a widespread feeling among people and organizations. An unprecedented health crisis – coupled with accelerated globalization, which has allowed its exponential growth – has turned any glimpse of predictability into a distant future for almost all economic sectors. Habits, customs, and convictions had to be unlearned and relearned.

Among the many changes accelerated by Covid, the **dissemination of technological tools in the workplace** has undoubtedly been one of the most striking.

As in many other professions, physical contact in day-to-day legal work has been replaced with remote connection platforms, which allowed activities to be fully carried out without the need for travel and face-to-face meetings. In some companies, this was a difficult transition, but **with the help of ThinkFuture, TozziniFreire was already familiar with the use of technology on its daily routine**. Habits, customs, and convictions had to be unlearned and relearned.

During the following months when social isolation was necessary, **we continued working and quickly adapted** our events, meetings, and projects to the online format until we resumed face-to-face activities in 2022.

Data Analysis

Some say that data is the new oil, others argue that it is even more valuable. What we know for sure is that we are in the digital age and the amount of data in the world is growing exponentially every day, and the value of this information is becoming increasingly significant.

Despite the unquestionable power of data, research points out that only 40% is used for analytical purposes. This means that a large portion of the data generated is not converted into useful and valuable information.



Dashboards & BI

Data science projects delivered in dashboard format. We transform complex data into accessible and actionable information through customized dashboards that offer a **comprehensive view of the data used in the cases**.

Dashboards not only make it easier to understand data, but also allow for an in-depth analysis of patterns, trends and correlations that previously went unnoticed.



Legal data analysis

Legal data analysis projects to predict trends and patterns, **better understand legal flows and anticipate potential challenges**.

Insights through data can enhance our approach, examine the effectiveness of different legal strategies, and even predict points of attention in complex cases. **Data analysis** is a powerful tool, capable of revolutionizing decision-making and bringing numerous benefits to business operations, enabling more strategic decisions, better control of operational processes, understanding of customer desires and expectations, and more efficient business operations.

For this reason, our Advanced Solutions hub is dedicated to internal and external **Data Analysis** initiatives to guide clients and lawyers in making their decisions.

Litigation Analytics is one of our flagship projects. In 2020, to support our clients in their decision-making process, we developed a dashboard containing real-time data about the cases under TozziniFreire Advogados' representation. This allowed for checking the information in a quick, detailed, and intuitive way.

The **Privacy Track is an example of a project that combines legal data analysis with dashboard-style presentation**. In collaboration with the Cybersecurity & Data Privacy area, we have developed a technological platform for greater efficiency in projects for General Data Protection Law (LGPD, in Portuguese) compliance.

In addition to improving our lawyers' workflow, the platform has been used by clients to track and view legal recommendations.



Do you know the difference between jurimetrics and volumetrics?

Jurimetrics

Analyzing data to gain deep knowledge. Detecting patterns, trends, and insights in legal cases and case law. Predicting outcomes/scenarios and offering probabilities of occurrence.

As an example, we participate in projects invol **due diligences**, in which we analyze ongoing lawsuits, aspects of commercial contracts, contractual clauses that could have a negative impact on the transaction, among other aspects.

Volumetrics

Collecting data to understand the macro, volume-based scenario. Providing an overview of the legal case situations.

Automation

In addition to all this, our Advanced Solutions team works on the development of automation tools and decision trees to be applied to memos, legal opinions, and document creation, making it easier for clients to interact with the results.

Tax decision tree: reinventing the legal opinion One of the automation tools developed involved a legal opinion from TozziniFreire's Tax area. The partners identified a wide range of variants that changed the outcome of our recommendations.

To cover all the possibilities, the initial document to be delivered to the client would have been too lengthy, confusing, and not very intuit. Therefore, the ThinkFuture team was asked to rethink, alongside the Tax team, how to communicate this legal opinion in a more dynamic and intuitive way.

The solution found was to create a dynamic and automated decision tree, through which the client could build the memorandum in real time, directly on a platform developed and hosted by TozziniFreire.

digital transformation & legal operations hub

To conclude the retrospective of our three workstreams, we present the **Transformation & Legal Operations (Legal Ops) Hub**: a workstream dedicated to carrying out projects and initiatives that result in efficiency and productivity gains of legal areas at TozziniFreire.

Identify customized innovative solutions that can enhance, streamline, and transform the way we work.

Legal Ops is a concept that has become increasingly relevant in the legal field and is among the main innovative trends in the world of Law.

It involves a set of processes, activities and professionals dedicated to helping law firms and legal departments become true business partners to their internal and external clients, **optimizing their operations and increasing the efficiency and quality of the services provided**. To achieve this, it brings the legal world closer to methodologies and knowledge typical of Business Administration and Management, as well as technological solutions so that lawyers can focus solely on delivering the best possible legal services.

ThinkFuture is in constant dialogue with the various areas of the firm, to understand their key demands and identify customized innovative solutions that can enhance, streamline, and transform the way we work.

Take a look at some of the initiatives that are part of our Digital Transformation & Legal Ops hub:

Legaltech Follow-up

At TozziniFreire, the use of technology to internally transform processes is already a common practice. **There are countless technologies that enhance our daily work**, for instance, through electronic filing systems and legal cases updates, document reading and regulatory mapping.

In 2023, the law firm already has 51 technology solutions in place. However, we are constantly on the lookout for new solutions to make the services we offer more sophisticated, to add value to our clients and to solve internal pains identified in the provision of legal and administrative services within the firm.



TozziniFreire Pitch Week

In 2021, we held the first TozziniFreire Pitch Week.

The purpose of the event, which was attended by more than 30 companies, was to have participating startups present legal solutions to the firm's lawyers.

Eight LegalTechs were selected for follow-up after TozziniFreire's partners and lawyers have expressed their interest in them.

TFMerge

Document compilation platform developed from an idea brought by TozziniFreire lawyers. In 2023, we launched a tool designed especially for the day-to-day work of TozziniFreire professionals: **TFMerge**.

This project was created when we identified the need for our lawyers to have a mechanism at their disposal to compile all the documentation generated during the course of cases and after their conclusion. To meet this demand, **TFMerge** makes it possible to create documents by compiling PDFs, and to add a cover page, table of contents and bookmarks, for quick and dynamic navigation.

All of this is done securely and in compliance with our Privacy and Data Protection policies.

inbound innovation

This is a clear example of a culture of innovation: the project was conceived by a corporate lawyer who, by contacting ThinkFuture team, was able to follow its development and implementation.

Launch of TF/AILA project

Given the expansion and potential of generative technologies and with a task force made up of members of ThinkFuture and our IT Department, in May 2023 we began the pilot project to develop the platform named TF/AILA, TozziniFreire's Generative AI tool using OpenAI's GPT technology.

With the aim of streamlining routine tasks, we have created an internal and secure platform **to help our employees with repetitive, manual, low-complexity, and non-technical tasks** – for example, tasks such as drafting emails without legal consultation, requesting suggestions for improvements when writing messages, summarizing texts, rephrasing sentences, identifying keywords and creating lists and tables.

Make the work of lawyers and all the firm's other employees more efficient. The initiative, which is multidisciplinary in nature, aims to make the work of lawyers and all the firm's other employees more efficient, offering support in daily tasks without neglecting the sophistication of our professionals' intellectual work. TozziniFreire's Generative AI Tool using OpenAI's GPT technology. The system operates under strict Information Security and Privacy guidelines, in line with TozziniFreire's high standards. All the answers provided can be evaluated by users as to their accuracy, seeking to continually refine their potential. Launched in June 2023, the platform is beginning to be implemented through pilot groups consisting of lawyers and administrative staff selected according to their routines and potential for improvement through the use of TF/AILA.

Partnerships in the Legal Innovation Ecosystem

To bring our own team closer to the national and international legal innovation ecosystem, we have established several partnerships. National and international entities that are renowned for conducting initiatives related to innovation in Law and that align directly with the objectives of our program contribute to strengthening the pioneering spirit and leadership of TozziniFreire Advogados in the Brazilian innovation landscape.

Workshops

AB2L and Associates Innovation Workshop

November 2019

On November 7, 2019, at the Borges Lagoa office, in collaboration with AB2L, we held the workshop "Redesigning Law Firms." The meeting brought together 40 lawyers to understand the problems and concerns that impact their routines. Through debates and the exchange of experiences, solutions were proposed for redesigning law firms and reinventing the Law through Design Thinking techniques and a cultural transformation driven by the adoption of new technologies.

Legal Design Workshops

As a recurring initiative, we have conducted workshops to enhance the skills of our lawyers for them to improve communication with our clients, and we present new techniques for applying Visual Law to their work.

Excel and Data Science Workshop
