- We advised the Ontario Teachers' Pension Plan Board (OTTP) on the acquisition of 100% of Evoltz Participações S.A., a leading electricity transmission platform in Brazil, with seven lines totaling over 3,500 km across 10 states. This transaction was recognized as the 2021 Brazilian Transaction of the Year by Transactional Track Record (TTR).
- We advised SoftBank on investments in Brazilian startups, including CRM Bonus, Medway, and Trela.
- We advised ADM, Amaggi, Cargill, and Louis Dreyfus on the Series A-2 investment round of Grão Direto, a company that operates an electronic marketplace for grain trading.
- We advised Chan Zuckerberg Ventures on a BRL 25.8 million investment in Beep Soluções em Saúde S.A., a leading health tech company in home healthcare services.

- We advised MSW and Banco do Brasil on the formation of BB Ventures, a corporate venture capital fund designed to invest in technology startups.
- We represented Grupo Energía de Bogotá (GEB) and Argo Energia (companies controlled by Grupo Redeia and Grupo Energía de Bogotá) in one of the largest transactions in the Brazilian transmission sector, the acquisition of 100% control of five transmission concessionaires from Grupo Quantum/Brookfield. With this transaction, Argo doubles its size in transmission facilities.
- We advised Neoenergia S.A. on a BRL 1.2 billion M&A agreement for the sale of 50% of Neoenergia Transmissora 15 SPE S.A. (Target), which will serve as an investment platform between Neoenergia and Warrington. As a condition of closing the transaction, eight transmission companies will be transferred to Target. The agreement includes the evaluation of joint participation in future electricity transmission auctions conducted by ANEEL, in addition to the possibility of Warrington acquiring 50% of other electricity transmission assets, under construction or in operation, from Neoenergia.
